Introduction: What a publication scheme is and why it has been developed

One of the aims of the Freedom of Information Act 2000 (which is referred to as FOIA in the rest of this document) is that public authorities, including all maintained federations, should be clear and proactive about the information they will make public.

To do this we must produce a publication scheme, setting out:

- The classes of information which we publish or intend to publish;
- The manner in which the information will be published; and
- Whether the information is available free of charge or on payment.

The scheme covers information already published and information which is to be published in the future. All information in our publication scheme is available on paper form.

Some information which we hold may not be made public, for example personal information.

This publication scheme conforms to the model scheme for schools approved by the Information Commissioner.

This policy is read within the context of the Christian values and teachings of our Federation.

Aims and Objectives

The overall aim of our federation is to develop, in partnership with their parent/carers, happy, well-motivated pupils in a caring and stimulating learning environment. We strive to develop pupils who are well prepared to derive maximum benefit from their secondary education and who are ultimately fit for a life of work, leisure, family and community responsibilities.

- We constantly strive to raise standards and work hard to ensure that no child's progress is limited.
- We provide a curriculum that the children will find exciting, challenging and fulfilling. We aim to develop children with enquiring minds and the ability to question, reason and communicate.
- We recognise the range of experiences that children bring to school and the value these have.
- We believe that partnership between school and home is crucial to success. We greatly value support from parents and carers and know that good communication between home and school is essential.
- We know that children thrive on praise and encouragement and work hard to acknowledge their achievements.

Categories of information published

The classes of information that we undertake to make available are organised into four broad topic areas:

School Website - information published on website is available in HARD COPY through the school office. School Prospectus – information published in the school prospectus and available in HARD COPY from the office. Governors' Documents – information published in the Governors Annual Report and in other governing body documents.

Pupils & Curriculum – information about policies that relate to pupils and the federation curriculum. *Federation Policies and other information related to the federation* – information about policies that relate to the federation in general.
